We have an operating CCTV system to deter and prevent incidents. These have been strategically placed to cover the entrance and all key areas of the shop, Staff receive regular training in order to ensure the smooth operation of the CCTV coverage and recording. CCTV installed in the shop is solely for the purpose of staff and public/customer safety and will therefore only hold footage recording on a rolling 31 days basis.

c) Public safety *

Shorter customer facing opening hours as specified above. Customer shop collection till 01:00 delivery option available thereafter. Staff training on how to handle and record incidents if they do occur, filling in a incident register with as much information as possible, and contacting relevant authorities in case of an emergency.

d) The prevention of public nuisance *

Signage to remind customers of keeping the noise down and respecting the neighbours. We do not sell Alcohol or Play any music at our premises.

e) The protection of children from harm *

All children / minors should be under the supervision of their Parent / carer. There are no Activities or entertainment in/on the premises which would put children at risk. Here at Xpress Grill we take the safe guarding of children very seriously and there are no potential hazards in our shop. should the need arises, we are fully dedicated to take the necessary steps to create a safe environment for their safety and well being.
